#### The type of personal information we collect

We currently collect the following data during our course booking processes:

- Personal identifiers including but not limited to Full Name, Organisation, Email address and Job Title.
- Occasionally Teacher reference number

#### How we get the personal information and why we have it

We process personal data provided to us directly by you for the following purposes:

- As part of course bookings with Alban Education.
- For the purpose of sharing activities that you may have a legitimate interest in through our newsletter.

We use your information, from yourself and third parties, both for the following reasons:

- To subscribe users to our service or publications, including event invites and product or services marketing.
- To provide us with feedback.

#### Sharing your information

We may share this information with the following:

- Facilitators leading our training programmes.
- Training venues for the purposes of attendance records.
- Subject network delegates as and when agreed.



#### Lawful Bases

Under the UK General Data Protection Regulation (UK GDPR), the lawful bases we rely on for processing different types of information are:

(a) Your consent. Consent can be withdrawn at any time. You can do this by contacting **cpd@albaneducation.co.uk** 

(b) We have a contractual obligation.

(c) We have a legal obligation.

- (d) We have a vital interest.
- (e) We need it to perform a public task.
- (f) We have a legitimate interest.

Where the legal basis for processing is consent, for example direct marketing, you can withdraw your consent at any time, and we will cease to process the information further. Consent must be given on an opt-in basis, and it must be made clear at the point of giving consent that you can withdraw consent freely.

## **Special Category Data**

From time to time, we may process special category data, which under UK GDPR is defined as:

- Personal data revealing racial or ethnic origin.
- Personal data revealing political opinions.
- Personal data revealing religious or philosophical beliefs.
- Personal data revealing trade union membership.
- genetic data.
- Biometric data (where used for identification purposes).
- Data concerning health.
- Data concerning a person's sex life; and
- Data concerning a person's sexual orientation

If special category data is processed, then we will ensure that this is processed lawfully, fairly, and transparently complying with all the other principles and



requirements of the UK GDPR, which also includes meeting one of the specific conditions in Article 9 of the UK GDPR.

#### How we store your personal information

Your information is securely stored. We store all information in a cloud-based management information system. Access to your data is restricted, with limited staff having access. We hold your data in line with our data protection policy found <u>here</u>.

#### Your data protection rights

Under data protection law, you have rights including:

- Your right of access You have the right to ask us for copies of your personal information. You can do this by submitting a Subject Access Request (SAR).
- Your right to rectification You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.
- Your right to erasure You have the right to ask us to erase your personal information in certain circumstances.
- Your right to restriction of processing You have the right to ask us to restrict the processing of your personal information in certain circumstances.
- Your right to object to processing You have the right to object to the processing of your personal information in certain circumstances.
- Your right to data portability You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

If you make a request, we have one month to respond to you. If the request is deemed complex, we may extend the deadline by up to a further two months; you will be informed promptly if this is the case.
